

The Saudi Quality Mark (SQM) is a prestigious certification approved by the Saudi Standards, Metrology and Quality Organization (SASO). It signifies that an organization implements an effective Quality Management System (QMS) and guarantees that products are manufactured in accordance with Saudi standards and technical regulations.

Companies must register and apply through SASO's electronic certification platform.

Document Submission

Required documents such as commercial registration, industrial license, and quality management system certificates must be submitted.

SASO evaluates the submitted documents and assesses product compliance with Saudi standards.

On-Site Inspection

Production facilities are audited, and product samples are collected for testing.

Decision and Licensing

Upon successful evaluation, a Q-MARK license valid for three years is issued.

The WATER SLS - EER Certificate is a prestigious certification awarded to systems that optimize water and energy efficiency, ensuring they are environmentally friendly and safe. The Emirates Authority for Standardization and Metrology (ESMA) is the national standardization body responsible for monitoring the compliance of products exported to Dubai and the United Arab Emirates (UAE) with local standards and regulations. It oversees the implementation of product safety, quality, and environmental compliance standards within the UAE. ESMA operates two main conformity assessment programs:

- ECAS (Emirates Conformity Assessment Scheme): A mandatory conformity assessment program.
- EQM (Emirates Quality Mark): A voluntary or, for some product categories, mandatory quality certification program.

How to Obtain Certification?

- Application and Document Review

 Exporters must submit technical documentation and test reports related to the product.
- Product Testing and Inspection
 Safety and quality tests are conducted for items such as electrical appliances, cosmetics, food, and toys.
- Factory Audit (If Required)
 For certain products, on-site inspection of the manufacturing facility may be necessary.
- Certification Issuance
 Products that successfully pass tests and inspections are awarded an
 ECAS or EQM certificate.
- Compliance Marking (EQM)
 Certain products are released to the market bearing the Emirates
 Quality Mark (EQM) label.







Thanks to these conformity programs managed by ESMA, products can be placed on the UAE market without obstacles and are ensured to be safe and reliable for consumers.

EGAC / GOEIC THE KEY TO ENTERING THE EGYPTIAN MARKET

The GOEIC certificate is a mandatory document that certifies products meet Egypt's national standards for quality, safety, and legal compliance.

How to Obtain the Certificate?

- Application: Required documents are submitted to GOEIC through their online system or via an authorized representative.
- Evaluation: GOEIC reviews the technical specifications and verifies the submitted documents. Additional documents may be requested if necessary.
- Product Testing: When required, products are tested in laboratories accredited by Egyptian authorities.
- Approval and Registration: Once all requirements are met, the company and products are registered in the GOEIC database.
- Certificate Issuance: After a successful evaluation, the registration certificate is issued.

For companies exporting to Egypt, the Certificate of Conformity (CoC) is a legal requirement. This certificate confirms that products comply with Egypt's health, safety, and quality standards prior to shipment.

The process is regulated by GOEIC (General Organization for Export and Import Control) and involves inspection and testing of products before they enter the Egyptian market. Authorized certification bodies are responsible for issuing the CoC for compliant shipments.

As an authorized body, Ezhar Kurumsal ensures your export process is fast, reliable, and fully compliant with Egyptian regulations.

IRAQ COC CERTIFICATE THE KEY TO COMPLIANCE AND MARKET ACCESS

The Certificate of Conformity (CoC) is a mandatory document for exporting to Iraq and Morocco, proving that your products comply with national standards and regulatory requirements. Without a valid CoC, goods cannot be legally imported and may be delayed or rejected at customs.



CoC Service Process

- Application and Document Review
 - The exporter must send the technical documents, invoice, and images related to the product.
 - The documents are checked for compliance with the standards of Iraq.
- Application and Document Review
 - The products are subjected to laboratory tests to ensure compliance with the technical regulations of the importing countries.
- Production and Shipment Monitoring
 - If necessary, the production processes and shipment preparations of the products are inspected on-site.
 - Before shipment, the products are checked, and transportation conditions are documented.
- Issuance of CoC Certificate
 - Based on the test and inspection results, the product's compliance is confirmed.

FAS COC SERTIFIKASI

For companies exporting to Morocco, the CoC (Certificate of Conformity) is a mandatory document that certifies products comply with the technical regulations and quality standards of the Kingdom of Morocco. Morocco manages this process digitally through the official portal www.portnet.ma, where all documents are submitted and reviewed.

How Does the CoC Process Work?

- PORTNET Registration and Application
 - The exporting company registers on Morocco's official foreign trade portal, <u>www.portnet.ma</u>, and initiates the CoC application.
 - Documents such as the commercial invoice, technical product files, test reports, and product images must be uploaded to the system.
- Assignment of CB Office and Inspection Planning
 - A Certification Body (CB Office) authorized by the system is assigned to handle the process.
 - The assigned CB evaluates the product's compliance with technical regulations and, if necessary, performs an on-site inspection at the production facility.
- Product Inspection and Testing
 - Depending on the product category, physical inspections, laboratory tests, or pre-shipment checks are carried out.
 - Products are assessed for compliance with NM (Norme Marocaine) standards.
- Issuance of the CoC Certificate
 - For products that meet all conformity criteria, the assigned CB issues the Certificate of Conformity (CoC) digitally.
 - The certificate is uploaded directly to the PORTNET system, allowing customs clearance to proceed smoothly.

ECTN / BSC MANDATORY CARGO TRACKING DOCUMENTS FOR EXPORTS TO AFRICA

ECTN (Electronic Cargo Tracking Note) and BSC (Bordereau de Suivi de Cargaison) are mandatory shipment tracking documents required for exports to West and Central African countries. These documents must be prepared and submitted to the relevant authorities before the cargo arrives at the destination port.

Why Are They Required?

- Legal Obligation: Shipments without these documents may be rejected, delayed, or fined.
- Faster Customs Clearance: Advance information helps speed up port procedures.
- Transparency: Details of the goods, shipper, consignee, and carrier are clearly recorded.

The program is managed by the respective national standards authorities of each country.

- Application: The exporter prepares technical documentation, invoice, and product certificates.
- Testing & Inspection: Products are tested by authorized bodies, and if necessary, on-site inspections are conducted at the production facility.


